WHITE ELECTED BREC VICE CHAIRMAN

Bob White, a past president of the Homebuilders and Contractors Association of Brevard County, won a runoff election at the May 13 BREC meeting to become the new vice chairman. He succeeds Dave Isnardi, who had to resign for family health reasons.

White defeated James Marshal, president of the Brevard Republican Men's Club, by 25 votes on the second ballot. The three-way race on the first ballot, in which no candidate received a vote majority, also included Constitution supporter Mark Vance.

A member of the Republican Liberty Caucus of Central East Florida, White says his goal, working with BREC chairman Barbara Davis, is to help build up our organization's membership.

Other highlights of the May 13 meeting were:

-- Linda del Gallego announced she is looking for volunteers to staff the headquarters building several hours a week to help give the county a greater awareness of our presence.

-- The Council of Clubs Republican Family Picnic will be held on Saturday, June 5th from 12:00 pm to 4:00 pm at the Wickham Park Main Pavilion. This event is being organized this year by the Republican Women's Network of South Brevard.

-- Flyers were handed out for BREC's Day of Golf, which will be held August 14 at the Duran Golf Club beginning at 8 am and will include a Grand Buffet Awards Lunch. Local candidates will be on hand for

the event, to take place just ten days before the primary election.

-- It was announced that U.S. Senate candidate Marco Rubio's campaign has opened its campaign headquarters for Brevard County, located at 1499 S. Harbor City Blvd. in Melbourne.

-- Vice Chairman Bob White swore in eight new members to the executive committee.



GOODBYE, CHARLIE

As expected, reaction to Governor Charlie Crist's decision to bolt from the Republican Senate primary election has been strong and vocal.

It was no surprise to anyone – once the polls showed challenger Marco Rubio with a double digit lead over Crist in the race for the August 24 primary nomination – that the governor would change directions. On May 12, he signed documents changing his status on the voter rolls in his hometown from “Republican” to “none,” and stated he had no plans to return any campaign funds requested by Republican donors.

The on-line Patriot Post writes, “Crist does have the legal right to hang onto the money, but it sure seems sleazy and desperate. Perhaps the spigots are about to run dry.”

Crist was criticized heavily for embracing President Obama's economic stimulus package, and was considered an unreliable partner in the fight against the

Democratic agenda in Washington. There also has been a year of mounting distrust between the governor and the Republican leadership in Tallahassee, culminating in his legislative vetoes.



As soon as Crist announced he would wait until November to run in the general election as an independent, Republican Party Of Florida Chairman John Thrasher ordered the removal of the governor's official portrait from party headquarters in Tallahassee. The portrait was auctioned on e-Bay and sold to an anonymous registered Republican for \$7,700.

RPOF Executive Director Ronnie Whitaker sent notice to all county Republican committees reminding that members are prohibited from supporting a candidate running with no party affiliation over the Republican candidate chosen in a primary election. "Any member who fails to formally revoke his or her public support and request the return of any contributions made to a candidate running against the candidate of the Republican Party would be in violation of the RPOF rules and would be subject to removal from party office and membership," Whitaker wrote.

Rubio says Crist is "more concerned about political self-preservation than the people of Florida." He adds, "You're never going to be able to hold him accountable to anything, because his opinions are going to change based upon what polling tells him and what his political convenience tells him."



Former Arkansas Governor Mike Huckabee, now a Fox News commentator, says he believes most Florida voters in November will "proudly cast votes for conservative Marco Rubio to win the U.S. Senate seat – a candidate who still knows what he believes and why he believes it." Noting that the Republican Party is at a crossroads, Huckabee added, "Gratefully, the politics of opportunism and self-preservation that have dominated our representation in Washington for too long are being swept away in race after race by a new generation of principled, conservative leaders."

Senator George LeMieux says his friendship with Crist "runs deep, but my commitment to the principles of the Republican Party runs deeper. I cannot walk down the path he has chosen."

BREC Chairman Barbara Davis says she is "very disappointed" with Crist, adding, "He let his personal political career take precedence over the party. I do not believe Crist will be able to take away Republican votes. Our party is strong and energized."

Calling him "an opportunist," former BREC Chairman Ray Marino says, "I supported Crist for governor and I regret that I did. He got a taste of running with the beautiful people and he became one of them."

Writing in [American Spectator](#) on line, Larry Thornberry says, "Crist is a political lightweight who has held a succession of Florida offices in flush times, won mainly on the basis of a pleasing manner, a good shoe-shine and a facility to convince Florida voters that he just L-U-Vs them. As the situation requires, Crist is comfortable being conservative, liberal, moderate, populist, vegetarian, high-church, low-church, no-church, or fill-in-the-blank. He bats and throws left, right and center."

The [Atlantic Magazine](#) says on its website that prior to his announcement, Crist tried through intermediates to reach White House chief of staff Rahm Emanuel but the White House refused to take the call. The implication, according to the magazine, is that the Democrats weren't interested because they plan to campaign strong for Congressman Kendrick Meek, their candidate in the Florida Senate race.

Reacting to liberal journalists who say Crist was victim of a "Stalinesque purge" by the GOP, [Media Research Center](#) President Brent Bozell says on CNSNews.com that "these journalists are either totally naive or dishonest. Either way, they are creating a false impression. There's a difference between a 'purge' and the popular will. Stand for election, and then accept the results."



Asked on NBC's "Meet The Press" whether, if elected, he would caucus with Republicans in the Senate, Crist's side-step response was, "I will caucus with the people of Florida."

TAMPA CHOSEN AS THE SITE FOR THE 2012 REPUBLICAN CONVENTION

The RNC Site Selection Committee has chosen Tampa as the location for the 2012 Republican Presidential Convention, and the full RNC vote on the decision at the August summer meeting is expected to be a formality.



RNC Chairman Michael Steele says the party is "honored and privileged" to accept Tampa's bid...that we are confident will produce a successful event."

Sharon Day, the RNC Secretary, says that since her native Florida is a bellwether state, "we'll be stronger for 2012. It will give us an opportunity to strengthen our volunteer base."



The 13-member site committee selected Tampa over two other finalist cities – Phoenix and Salt Lake City – after looking at such factors as the number and proximity of hotels, capacity of the arena to hold the convention, transportation, security, media work space, convention office space and the ability to finance the operation.

The convention will take place the week of August 27, 2012, in the 660,000-square foot St. Pete Times Forum, home of the Tampa Bay Lightning.

[WSJ/NBC POLL FINDS VOTERS SHIFTING TO REPUBLICANS](#)

According to the latest Wall Street Journal/NBC News poll, the Republican Party is in position for a strong comeback in November mid-term balloting, by solidifying support among voters who had drifted away in recent elections. This group includes independents, seniors, blue-collar voters, suburban women and small town and rural voters.

Republican pollster Bill McInturff, who co-conducted the bipartisan survey, says the Republican alliance appeared to be "firmer and more substantial" than earlier in the year.

The May 6-10 telephone survey covered a cross-section of 1,000 adults nationwide. But while the results foreshadow a strong showing for Republicans, they also show that voters were far more motivated by their frustration with Democrats and government in general.

Among those polled who preferred Republican control of Congress, 64 percent expressed opposition to the Democrats as the reason, while 31 percent supported Republican candidates and policies.

Among those polled who preferred Democratic control, 49 percent expressed support of Democratic policies and 48 percent said the reason was opposition to Republican policies.

Of the respondents who said they have a high level of interest in the election, the margins were 56-36 percent in favor of the Republicans.

On the subject of offshore drilling, 60 percent of respondents support it, and 34 percent oppose it.

On the subject of Arizona's recently adopted anti-illegal immigration law, 64 percent of respondents supported it and 34 percent opposed it.

JUDICIAL CANDIDATES APPEAR BEFORE NEW MILLENIUM CLUB

Four candidates for two judicial positions in Florida's 18th Circuit stressed before a meeting of the New Millennium Conservative Club that if elected, they would not be activists who legislate from the bench.

All judicial candidates in Florida run non-partisan in primary elections and are not allowed to publicly express party affiliation or their positions on issues. The 18th Circuit covers Brevard and Seminole Counties.

Clayton Simmons of Seminole County, the only incumbent in the group, was appointed to the bench by former Governor Jeb Bush in 2003 and re-elected to a six-year term the following year. He said it "takes courage" to be a judge and have to make those "tough decisions."

Simmons was the circuit's chief judge for two years. Earlier, he was an attorney in Seminole County and in the U.S. Air Force and Air Force Reserve.

He serves in Group 24 in the 18th Circuit, and is being challenged by Linda Schoonover, a Lake Mary attorney with 25 years experience in civil matters and is board certified in marital and family law.

The candidates for the circuit's Group 3 are seeking to fill an open vacancy on the court due to retirement. Oscar Hotusing of Merritt Island was appointed to the

court in 2006 but lost a reelection bid in 2008. The former assistant state attorney and attorney in the U.S. Army Reserve is being challenged by Jessica Recksiedler of Lake Monroe, a board certified civil trial attorney. A third candidate for the position, Carsandra Buie of Sanford, was unable to attend the New Millennium Conservative Club forum.

PLANS URGES STATE LEGISLATURE TO ENFORCE 10th AMENDMENT

Barry Plans, president of the Ronald Reagan Clubs, stressed at the clubs' April meeting that the State legislature needs to support enforcing the 10th Amendment. Current efforts in apparent support of states' rights, he said, seem to be simply "window dressing for vote getting."

At the federal level, Plans added, cap and trade, which would decimate the economy again, is "way out of jurisdictional bounds." The federal government, he said, has no power to regulate oil drilling on state property.

Plans showed the membership a video that pointed out the 17th amendment allowing U.S. senators to be elected by the people instead of appointment by state legislatures "empowers the federal government to violate states' rights because it enables senators to avoid accountability to their states."

Regarding the 2010 gubernatorial race in Florida, Plans made a pitch for a new conservative Republican in the race – Naples businessman [Rick Scott](#). He said Scott is a retired attorney who started Columbia Hospital Corporation, which shares ownership with physicians, and he used his own funds to help fight Obamacare.



Mark Vance told the meeting that the federal Supremacy Clause does not apply to Obamacare and that the Constitution explains that federal powers are few and well defined. He urged the group to stand up for states' rights and to keep pressure on our legislators.

POLITICAL JOTTINGS AND DOTTINGS

-- Clerk of the Court Scott Ellis is stepping down from his post on December 31, two years before the end of his current term, and plans to spend his time between his home in Brevard County and a farm in West

Virginia. To fill the unexpired term of the vacancy, a special election will be part of the August 24 primary and the November 2 general election. Republicans vying for the position include [Joanne Corby](#), Melbourne City Council member; [Matt Collins](#), former aide to County Commissioner Andy Anderson; and former State Representative [Mitch Needelman](#).

-- IT specialist [Matt Nye](#), a candidate for the County Commission District 4 seat, says if elected, he would prioritize county spending, which he says is "out of whack." Nye told a meeting of the New Millennium Conservative Club that during the past 10 years, even with a 164 percent increase in tax revenue collections, spending by the commission has put Brevard County in a deficit. Nye is challenging incumbent Commissioner Mary Bolin in the August 24 Republican primary.



-- Radio Talk Show Host Andrea Shea King spoke to the Melbourne Area Federation of Republican Women of Melbourne about her recent experience aboard the Tea Party Express national tour. She said highlights of the trip included meeting Sarah and Todd Palin; joining Lloyd Marcus and patriots holding umbrellas in a Kansas downpour in a rendition of "I'm Singing in the Rain;" seeing how disappointed Michiganders were about Congressman Bart Stupak's failure to stand for the unborn and the people who elected him; and how the Tea Party prayed as a group before each rally.

-- The conservative think-tank [Heritage Foundation](#) cannot actively promote legislation, but has started a new grassroots advocacy group called Heritage Action for America, which will do so in the name of free enterprise and limited government. Heritage President Ed Feulner says this is an independent organization "with the shared mission of promoting sound conservative policies."



-- [National Review](#) magazine's [biannual Post-Election Cruise](#) will include seminar remarks by author and former White House aide Karl Rove, conservative icon Phyllis Schlafly, web guru Andrew Breitbart, media critic Bernie Goldberg, syndicated columnist Tony Blankley, and a host of additional analysts and NR editors. The cruise, on Holland America's Nieuw Amsterdam to the Caribbean out of Ft. Lauderdale, will take place November 14-21. For details on joining the group, visit www.nrcruise.com.

-- [The National Rifle Association](#) notes that an estimated 20-30 million American gun owners and hunters are not registered to vote and is calling for them to do so, and join freedom's army. NRA president Ronald Schmeits says our elected leaders need to hear and heed their constituents – not their political cronies and party bosses – and if they undermine the freedoms guaranteed by the Bill of Rights, they need to be stopped on Election Day.

-- National Public Radio's editor has told the staff not to use the term "Pro Life" in their copy, but instead say "Abortion Rights Opponents." By that "logic," would those of us who believe in democracy be labeled "Socialist Rights Opponents"???

Talk Show Host Sean Hannity, writing in the preface of his new book "Conservative Victory":

In response to the political and social upheaval of the 1960s, The Fund for American Studies has been educating young leaders on the values of freedom and free-market economies for the past 43 years.

Based in Washington, DC, the organization brings college students together for a summer or a semester to engage in a rigorous examination of economic concepts, political systems and moral philosophy. It recently expanded its program to sponsor institutes in the Czech Republic and Greece.

Since the quality of public discourse in a free society depends heavily on the accuracy of information provided by the news media, one of the programs—the Institute on Political Journalism—offers college students the opportunity to apply basic ethical principles to their reporting and have the tools to accurately cover issues involving economic concepts.

In mid-November, TFAS will hold a leadership network conference in Palm Beach. Last year's event was held in California, to celebrate the life of Ronald Reagan at the Reagan Ranch and the Reagan Presidential Library.

Board Chairman Randal Teague and President Roger Ream, writing in TFAS' publication "Teaching Freedom News," say that keeping the ideas of limited government, the rule of law and free markets alive in future generations is critical.

"We take this challenge very seriously because we know we can make a difference," they say, adding that as they visit with alumni of their programs, "we hear repeatedly that the professors they encountered in our programs were the best they ever had."
